Exploring the Future at DA Z: Art, Tech, and Beyond

DAOs - Rethinking Decentralized Power

I spoke at a workshop at <u>ETH Zürich</u> on 21st November, joined by panelists from Polygon and Sielva Management. Together, we delved into the DAO concept, provided insights into existing DAOs, and engaged in discussions about the future challenges related to legal aspects, community and technology.

As the number of DeFi projects continues to rise, so does the prevalence of Decentralized Autonomous Organisations (DAOs). The emerging corporate model of DAOs offers advantages suited to the digitalization and decentralization era. However, given the absence of specific legal frameworks for DAOs in most countries worldwide, their understanding and classification often remain speculative.
